

TERMS of the “smartCONNECTED” special offer

The “smartCONNECTED” special offer gives Customers the opportunity to purchase WIŚNIEWSKI products listed in § 3 paragraph 4 together with an integrated smart control device.

§ 1. General provisions

1. The organiser of the special offer is WIŚNIEWSKI Sp. z o.o. S.K.A. with its registered office in Wielogłowy (Wielogłowy 153, 33-311 Wielogłowy), entered into the register of entrepreneurs of the National Court Register kept by the District Court for Kraków-Śródmieście, 12th Commercial Division in Kraków under file number: 0000431405, Tax Identification Number (NIP): 734-35-13-091, REGON No.: 122453276, hereinafter referred to as the Organiser.
2. The special offer is not a lottery.
3. The special offer is organised within the territory of the European Union.
4. The special offer is valid for orders placed between 18 September 2017 and 30 November 2017.
5. For the purposes of these terms, the following definitions shall apply:

Special offer: bonus sales of selected WIŚNIEWSKI products listed in § 3 para. 4 of these terms.

Customer (Special Offer Participant): a natural person (consumer) purchasing a WIŚNIEWSKI product – included in the special offer – listed in § 3 para. 4 of these terms – for personal use, purchasing products listed in § 3 para. 4 of these terms, which are not the subject of further resale, meeting the conditions set forth in § 2.

Point of Sale: a point of sale of a Trading Partner located in the European Union outside of the Republic of Poland.

§ 2. Conditions of participation in the special offer

1. The special offer is addressed to individuals who meet the following conditions at the time of taking part in the special offer:
 - a) are at least 18 years of age;
 - b) have a permanent residence within the territory of the European Union;
 - c) have a full legal capacity;
 - d) place an order for a selected WIŚNIEWSKI product included in the special offer.
2. Participation in the special offer is completely voluntary.

§ 3. Terms of the special offer

1. Each Participant who places an order for a WIŚNIEWSKI product/WIŚNIEWSKI products listed in § 3 para. 4 of these terms between 18 September 2017 and 30 November 2017 takes part in the special offer.
2. Transactions (orders) dated before 18 September 2017 and after 30 November 2017 will not be taken into consideration as part of the special offer.
3. The special offer includes only the products included in the offer purchased at a Point of Sale.
4. The terms of participation in the special offer are as follows:

- a) when ordering a sectional garage door with the METRO WIŚNIEWSKI Powered by Somfy drive unit, by paying EUR 99 extra, the Customer may purchase the sectional door in the smartCONNECTED version with the METRO io drive unit and the Connexoon device; and/or
- b) when ordering the CREO or DECO external aluminium door with the electric lock, by paying EUR 99 extra, the Customer may purchase the CREO or DECO external aluminium door in the smartCONNECTED version with the Lock Controller io and the Connexoon device; and/or
- c) when ordering a sliding gate with drive unit AWSo 2000 M4 230V in the post, the Customer may purchase the above-mentioned gate in the smartCONNECTEDio version with drive unit AWSo2000 M4 230V integrated in the post and with Ri-Co Pro controller by paying EUR 39 extra; and/or
- d) when ordering a sliding gate with the external drive unit (BFT Deimos) by paying EUR 99 extra, the Customer may purchase the above-mentioned gate with the SomfyElixo 3S io drive and the Connexoon device; and/or
- e) when ordering a double-leaf gate with the linear drive unit (BFT PHOBOS BT A 40) by paying EUR 99 extra, the Customer may purchase the above-mentioned gate with the SomfyXengo 3S io drive and the Connexoon device; and/or
- f) when ordering together sectional garage door with the METRO drive unit and the CREO or DECO external aluminium door with electric lock, the Customer will receive smartCONNECTED version with no extra charge (version io Metro drive unit, Lock Controller io and the Connexoon device); and/or
- g) when ordering automatic fencing gate and at least 10 m of fencing segments in the same design version as gate or 50 current meter complete VEGA welded mesh panel fences (mesh panels, posts, accessories) the Customer will receive smartCONNECTED version with no extra charge (Ri-Co Pro drive unit in the post AWSo2000 M4 230V or Connexoon device in case of gate with drive unit SomfyElixo 3S io or SomfyXengo 3Sio); and/or
- h) Special offer concerns sliding gate and double-leaf gates in the systems HOME INCLUSIVE, MODERN, LUX, PREMIUM, STYLE, VARIO, CLASSIC.
5. All the models of the products referred to in para. 4 of this article are available in all colours, design versions, and dimensions.

6. The applicable tax rate shall be added to the above prices.

§ 4. Complaints

1. Complaints concerning the special offer may be submitted in person or by mail to the Organiser's address provided in § 1 para. 1 of these terms or via e-mail to: promocja@wisniowski.pl within 2 (two) months from the date on which the basis for the complaint arose, and "smartCONNECTED" should be entered in the subject line.

2. Only the complaints submitted within the above-mentioned time limit shall be subject to investigation.
3. The complaint submission should contain the Claimant's detailed data and the description of the basis for the complaint together with its justification.
4. Complaints shall be investigated by the Organiser within 14 days from the date of receiving the complaint from the Claimant.
5. The Claimant shall be informed about the result of the Complaint in writing via registered mail sent to the Claimant's address provided in the complaint submission.
